About NIATx

This report is part of a group called the NIATx (Network for the Improvement of Addiction Treatment) Reports. NIATx works with addiction treatment providers to make more efficient use of their capacity and shares strategies for improving treatment access and retention. NIATx works with its member organizations and the field at large to improve treatment through organizational changes that address four aims:

- 1. To reduce the wait time between a client's first request for service and the first treatment session
- 2. To reduce client no-shows
- 3. To increase addiction treatment centers' admissions
- 4. To increase the treatment continuation rate between the first and the fourth treatment sessions

Current Report

The current report presents the aim of reduction in wait time for consumers entering **outpatient** treatment. In order to use this report, an agency must be entering transaction type 27s into ICIS, which represent the First Contact. The objective of this measure is to determine the amount of time from the consumer's initial contact with the agency, by phone or in person, until the consumer's initial assessment appointment. See the FY08 ICIS Manual for more information on transaction type 27. The information in this report is shown by month and broken out by satellite and age group.

Definitions

- Average Days represents the average number of days from contact to assessment for a given month in days.
- 1st Contact represents a count of all contacts for a given month.
- Assessments represents a count of all contacts that were followed up with an assessment for a given month.
- Days to Assessment represents the number of episodes falling into each category of length of time between contact and assessment. For example, the first column labeled "Same Day" represents a count of all episodes in which the contact and assessment occurred on the same day.
- No Assessment indicates the number of contacts that were not followed by an assessment.
- Percent represents the percent of contacts that became assessments within 30 days:

Count of Assessments

Count of Contacts x 100

• Unique Persons represents the number of individual consumers that were included in all episodes.

Notes

Drug Court clients have been excluded from the overall total for all contract sources because many agencies have court-imposed timelines and very little control over the admission process. However, data for the Drug Court contract source was included where there was a transaction type 27, admission and a first service under the Drug Court contract source.
